Notice of **not less than one full school term is required before removing your child from Fleming Pre-Primary / Early Learning Centre.** If timeous notice is given however, a pro-rata refund where parents have paid an annual fee will be executed. Failure to give a term's notice however will result in **one term's fees becoming payable.**
